KEY TALKING POINTS IN TODAY'S MEETING

TTF Affiliates initiative

- The idea is to expand TTF to other countries by recruiting people that wish to operate as affiliates and help lead TTF in their country
- USA, Canada and Australia are of greatest interests as they have legal and financial systems most akin to the UK's, so our approach is most easily adaptable to them
- Consideration needs to be given to existing organisations in each country that do similar work to TTF; is there a gap that needs filling?
- Consideration needs to be given regarding governance, for example in relation to:
 - What would the entity be?
 - o Potential reputational risks
 - Potential litigation risks (particularly in the USA)
- Action for Andy continue to have conversations with interested individuals without formally launching anything yet; feed in the feedback received at the next Advisory Meeting

The Woodford scandal

- FCA regulatory failures in the past relating to Arch cru, Connaught and Capita Fund Management, all of which contributed to the scandal, means the FCA is 'part of the problem'
- The FCA are failing to adequately protect consumer interests
- The FCA is wrongly promoting a Scheme of Arrangement as the best way forward, without properly explaining the counterfactuals e.g. the Financial Ombudsman Service and the Financial Services Compensation Scheme
- The FCA is withholding information from investors that would be helpful to them in deciding whether/how to vote on the Scheme of Arrangement

- TTF is actively involved through the sub-brand it operates, the Woodford Campaign Group
- Mark Bishop and Andy Agathangelou gave evidence at the Court Hearing on 12th October and will be giving evidence at the Sanction Hearing in January
- The situation is ongoing; TTF doing all it can to help investors' interests
- Action for Andy and Mark update at the next Advisory Group meeting
