My name is Andy Agathangelou, I am the founder of Transparency Task Force (TTF). We're a non-profit campaign group with a mission to promote ongoing reform of the financial sector so that it serves society better.

TTF, together with Annette Riding, a member of the Victims of McClure Solicitors Facebook campaign, are organising an online event to address the ongoing challenges faced by former McClure clients and to discuss actionable solutions, and we would like to invite you to participate.

The event is on Tuesday, 12th November, 6pm-7:30pm on Zoom.

Our discussion will focus on the current state of affairs for ex-clients of McClure Solicitors and the extensive obstacles many continue to face. We will also address systemic issues highlighted by this situation, such as the need for increased accountability from intermediaries—financial planners, charities, and estate planners—who guided clients toward unfit financial products. The emotional and financial toll on affected families remains significant, with many clients still unaware of the precarious nature of their arrangements and some facing difficult legal battles and lost documentation.
